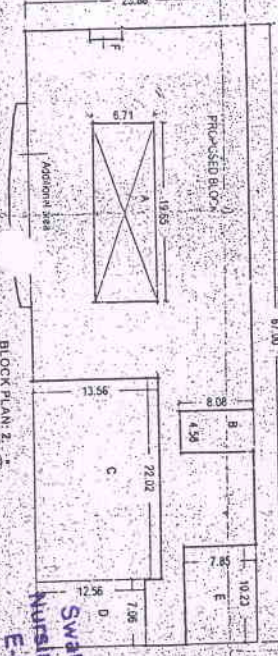

- b) Give written notice to the corporation regarding completion of the work.
 - c) Obtain an occupancy certificate from the corporation after duly completion of compound wall / fencing and building.
 - d) Permit authorised officers of the corporation to enter the building or premises for which the permission has been granted at any time for the purpose of endorsing the building Control Regulation and condition of the certificate.
- 3) The structural design, building materials, plumbing services, fire protection, electrical installations etc. shall be in accordance with the provision (except for the provision in respect of floor area ratio) as prescribed in the National Bldg. code amended from time to time by the Indian Standard institution.

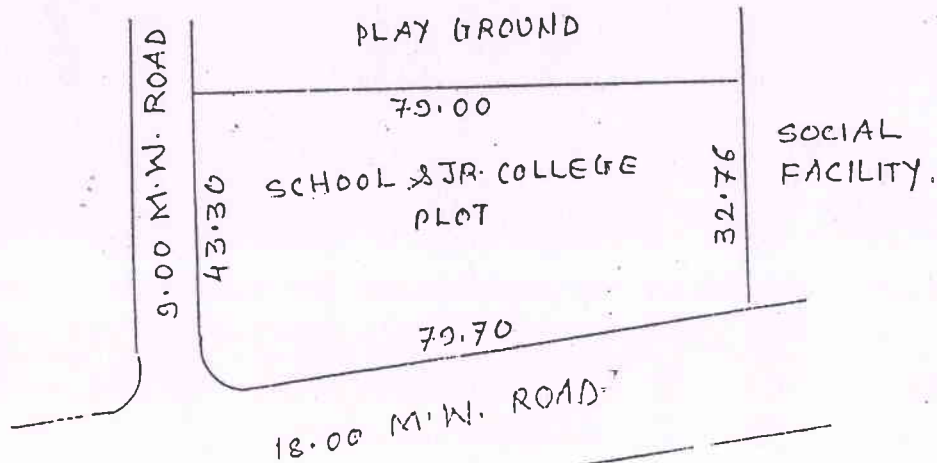


